



# SilverDust Australian Cattle Dogs

A PET puppy is defined here to be a Australian Cattle Dog puppy which is in good health at the time of sale, and embodies the characteristics of the Australian Cattle Dog breed . This PUPPY is purebred and is registerable (registered) with the American Kennel Club on a limited registration basis. PET puppies are not sold with any health guarantees other than guaranteed healthy at the time of sale.

A SHOW puppy is defined here to be a Australian Cattle Dog which is in good health at the time of sale and meets the AKC standard for the breed. Breed/show prospect shall be understood to mean that no disqualifying faults as defined in the standard are evident at time of sale and further that no genetic disorders are immediately apparant. This puppy accompanies the guarantee that he/she meets those breed standards for finishing his AKC American championship. The BREEDER assumes no responsibility for the dog's show success in the show ring, nor for finishing a championship in a foreign country; or meeting standards of a foreign country. If the dog is sold as a show dog, the BUYER will make every effort to finish the dogs AKC championship. Not showing the dog is not considered an effort and is a breach of contract.

If the SHOW puppy develops any breed disqualifications or develops hereditary conditions which determine the animal unfit for breeding in the United States of America, it will be replaced with a puppy from the next available litter IF the following conditions are met:

- The condition declared, and verified in writing by a licensed veterinarian and at the BREEDERS discretion, verification by other Australian Cattle Dog breeders of choice to deem that there is indeed a disqualification from the AKC standard.
- The condition is diagnosed on or before the age of 26 months.
- The dog or bitch has not been used for breeding purposes before 26 months.
- The original owner of the dog has not changed.
- All feeding and care recommendations have been followed.
- The dog/bitch must be spayed or neutered after diagnosis of disqualification or hereditary condition. BUYER to pay spay / neuter expenses. BUYER may keep spayed or neutered animal. If, instead, the dog is be returned to breeder, BUYER will pay all shipping expenses. After all requirements are satisfied, replacement puppy will be made. Buyer is responsible for any costs involved in shipping of a puppy/dog including shipping costs involved if the puppy/dog is returned for ANY reason. This includes show puppies that are unacceptable to the buyer for any reason, unless a health problem exists. This includes but is not limited to air charges and crates. PROPER NOTICE must be given before returning any puppy for any reason to insure that the seller will be available to pick up the puppy at the airport.

This PET puppy is registered with a limited registration, which will prohibit breeding and registering offspring. (The BUYER agrees this female PUPPY is to be spayed at the appropriate age, or male puppy neutered and veterinarian confirmation of this procedure must be supplied to the BREEDER.) \_\_\_\_\_ Please initial.

( Repeatedly means season after breeding season )

BREEDER guarantees that Puppy is in good health and has received appropriate medical inoculations, worming and care. BREEDER will provide BUYER with a medical chart detailing treatment Puppy has received under BREEDERS care, and any future care BREEDER feels is essential to Puppy's well being.

The BREEDER does not assume any liability for any injury to said puppy after delivery.

The BREEDER shall not be held responsible for the development of disqualifying faults, diseases, or disorders, which are due to BUYERS negligence.

BREEDER strongly recommends that Buyer attend obedience classes with Puppy and provide proper socialization opportunities for Puppy.

BREEDER shall not be held responsible for acts of Puppy, which are due to Buyers negligence.

The BUYER agrees to have this ( show or pet ) puppy examined by a veterinarian within 5 days of delivery. If the puppy is found to be other than healthy by the BUYER'S veterinarian, it shall be returned to the BREEDER immediately, and the purchase price will be refunded. Deadline for this refund is 5 days from delivery.

The BUYER agrees to maintain the puppy's health in good condition, and to provide yearly examinations, vaccinations, heartworm test, and any other usual procedures necessary to assure good health.

The BUYER agrees that neither he/she nor the BUYER'S estate/executors, or family may sell this PUPPY or transfer ownership of this PUPPY without the BREEDER'S knowledge. WRITTEN consent and attached copies of said contract will be provided to the new owner, upon written consent from BREEDER. \_\_\_\_\_ Please initial.

The BUYER agrees that this dog nor any of its offspring will ever be sold to pet shops, pet stores, puppy mills or given for auction.

The BUYER hereby agrees that if at any time the Buyer cannot take proper care of the puppy or keep the puppy for any reason on the BUYERS part, the BUYER must notify the BREEDER, the BREEDER will take the PUPPY back but there will be NO refunds of sale, and said puppy must be returned at BUYERS expense. \_\_\_\_\_ Please initial that you understand this statement - \_\_\_\_\_.

The BUYER agrees to notify the BREEDER of any changes of address during the PUPPY'S lifetime.

The BUYER agrees that the dog will reside at their home and will be an integral part of the family. The dog will not be kept tied, tethered or chained or otherwise abused. The dog will be kept in a fenced yard. This dog is NOT sold as a kennel dog, and will not live in a full time kennel; the BUYER must not at any time transport the dog in an open cargo area of a vehicle. This document constitutes the entire agreement between the Breeder and Buyer with respect to this sale. The Buyer's signature below indicates that he/she has read, agrees and does understand all the conditions of the Sales Agreement and Contract of Sale. In breach of this contract, including any terms listed here individually and or in whole, all guarantees are null and void and if the breach jeopardizes the health, safety and welfare of the puppy, dog, or bitch. The BREEDER reserves the right to reclaim the puppy, dog, or bitch immediately in order to protect the health and welfare of the animal. If the contract is breached, the BREEDER reserves the right to assume ownership permanently of the dog including AKC registration, and all health records in order to protect the welfare of the animal with the BUYER forfeiting all further rights to the animal and the cash consideration paid to the BREEDER as liquidated damages for the breach of this sales agreement. In the event that litigation is commenced to enforce the terms of this contract the BREEDER, being, Deb Casey, shall be entitled to the costs thereof; including, but not limited to, attorney fees, and all travel expenses incurred by her and her attorney. \_\_\_\_\_ Initial \_\_\_\_\_ indicates this paragraph as been read and understood.
